LL.M (FIRST YEAR)

List of the eligible candidates for admission to LL.M. Two Year Degree Programme for the academic year 2026-2027 is displayed on the Notice Board.

The candidate is required to collect the Admission form in (Prospectus), College Office Counter.

The College is offering the following specialization:

1. Business Law
2. Criminal Law and Criminal Administration

The candidate is required to submit (02) copies of Passport size photograph.

Guidelines for Admission

- 1) The candidates should fill up and Submit admission form in **Siddharth College of Law, office Counter, from 31st July, 2026 to 5th August, 2026 as per verification schedule. (Lunch Break from 1.00 p.m. to 1.30 p.m.).**
- 2) LL.M. Admission is subject to verification of documents. In case of incomplete and false submission of documents the candidate is not eligible / entitled for admission.
- 3) The candidates are informed to bring all original relevant documents for verification and scrutiny. The scrutiny of documents will be done in College Office.
- 4) Pre-Registration Form should be attached with the Admission

form at the time of Verification of document.

6) After approval of admission the Department of Law will provide details to the candidate for payment of Admission fees.

Fees Once Paid not be Refundable.

- Candidates whose names appear in the list for first round of LL.M. admission should take their admission within the prescribed date as per the schedule given hereunder.
- If they fail to take their admission within the prescribed date, their claim for LL.M. admission will be cancelled and the seat will be given to the next candidate in the subsequent round of admission according to the merit and eligibility norms of the University of Mumbai.

- Candidates whose Marksheets are in reserved/hold are required to get the stamp and signature of the concerned Principal on gazetted copy of the declared result.
- All candidates whose names appear in the list for first round of LL.M. admission at the University of Mumbai are hereby informed that if they are currently enrolled as LL.M. students at the University of Mumbai or any other University / College, it is mandatory for the candidate to cancel their previous admission within 5 days.
- If the candidate fails to comply with this requirement the candidate will not be eligible for subsequent admission.
